Reports

<u>Facility Coordinator</u>-Jim Garnhart-Main project for last year was replacing the mailboxes. A new camera system was also installed at the mailbox shelter. We have had no vandalism incidences since. Had to replace the water heater and the water tank at the clubhouse.

<u>Treasurer Report-</u>Sandy Perry-The bank balances have been read; Randy explained the board worked very hard to balance the budget without raising dues. States many costs to the HOA are due to vandalism.

<u>Web Site-</u>Sandy Perry-The host for our website is going out of business-Sandy researching new providers and will have it set up in the next few weeks.

Equestrian-Rachel Larson-Having a special presentation on Sunday March 5 by experienced NATRC competitors Bill and Diane Wingle of Franktown. Hoping to have a good turnout. Purchasing some new equipment for the arena.

<u>Welcoming</u>-Sandra Corrigan-Welcomes new homeowners to the neighborhood with a welcome basket. Asks if there are any homeowners with business that would like to include anything in the baskets to promote their business.

<u>Activities Committee</u>-Andrea Garnhart and Robin Pickering-Book Club/1st Thursday of the month. April-Easter Egg hunt at the clubhouse. 4th of July parade. Possible July homeowner meeting BBQ. October-Trunk or Treat. December-Holiday light contest.

<u>Architectural Review Report</u>-Randy Burns-Reminds homeowners to turn in ARC paperwork prior to beginning any projects.

Open Forum/Communications from Community Members: Please follow the meeting rules.

There is a nomination from the floor to elect the 5 nominees by a show of hands. There is a homeowner present with 20 proxies that votes no on this nomination.

A homeowner states there is a problem with some loose, viscous dogs that have attacked homeowners in the neighborhood. He plans to initiate a petition and go to the county to lobby for some animal control resources.

A homeowner asks why the board is paying an out of state management company \$11,000 for bookkeeping services. Is there not a local bookkeeping option that would do this for less expense? Also asks why the management company sends paper statements every month even if a homeowner asks them not to.

Homeowner asks if a "garden" needs approval from the HOA. Answer is no.

A homeowner asks that the HOA be dissolved, and the amenities and common areas be turned into a private club.

A homeowner asks about the Articles of Incorporation and states there should have been a vote by the home ownership to get them finalized. Tina O'Bryan states, based on her research, a vote is not necessary. It is a simple matter of updating the information and filing it with the state. Homeowner salutes those who came to the meeting and encourages homeowner participation. 3-minute time limit per person.
